Overview

Governor Lamont has announced that he will allocate \$2.7 million of the Governor’s Emergency Education Relief (GEER) fund, a component of federal CARES funding, to institutions of higher education (IHEs) to support the mental health of their students.

The presence of mental health issues among college students is at an all-time high. Fueled by COVID-19, its economic impacts, and mounting awareness of systemic racism and inequality, in Fall 2020 [39% and 34%](#) of college students reported symptoms of depression and anxiety, respectively. Furthermore, [83%](#) said that their mental health had recently negatively impacted their academic performance.

This unique moment represents an opportunity to strengthen ecosystems of support to reach the [85%](#) of students who do not engage in college-offered counseling. The [Task Force to Study the Policies and Procedures Adopted by Each Institution of Higher Education Regarding the Prevention and Treatment of Mental Illness in Students](#) recommended investment in “[Communities of Support](#)” that engage leadership, faculty, staff, and students in creating holistic, supportive ecosystems that go beyond individual counseling.

In recognition of unique needs on each campus, the funds will be used for “mini-grants” to eligible institutions. These grants can be used to increase access to care, provide education and improve awareness of resources, conduct training for faculty, staff, and students, or for other related uses. Grants will be administered by the Office of Higher Education (OHE), in partnership with the Department of Mental Health and Addiction Services (DMHAS) and the Office of the Governor (OTG).

Eligibility and Awards

Applications are open to non-profit undergraduate institutions with an endowment per student of less than \$100,000.¹ Eligible IHEs are assigned a predetermined maximum grant award based on their undergraduate student population and share of students receiving a Pell grant. There are four tiers of per-student funding: if less than 20% of students receive a Pell grant, an IHE will receive \$6 per student; 20-29%, \$12 per student; 30-39%, \$20 per student; and 40% and greater, \$30 per student.

Eligible Award Uses

Awards must be used to fund eligible uses, including:

Access to and availability of care: To supply sufficient capacity and technical resources to meet student demand for mental health services. IHEs may consider collaborations or formal contracting relationships with existing community providers to leverage existing resources.

Education and Awareness: To make students, staff, faculty, and any campus mental health coalitions aware of existing mental health services and programs that are available on campus, online, or through a community provider.

Training: To equip faculty, staff, campus mental health coalitions, and students with the skills and knowledge required to identify, support, and respond to students with mental illnesses, developed with consideration given to the students' race, cultural background, sexual orientation, gender identity, religion, socio-economic status or status as a veteran or service member of the armed forces of the United States.

Other: Other uses will be accepted provided that the funding is used to meet the stated evaluation criteria, including activities outlined in [Section 3 of PA 21-132](#).

Selection

The selection committee will evaluate applications using the following criteria:

1. *Evidence-Based Practice:* Applications have a base of evidence-based practice and/or research to support the program's effectiveness
2. *Collaborative Partnerships:* Applications are jointly developed across multiple campuses and with other partners (on- & off-campus) to ensure the maximum number of students are reached
3. *Sustainable Outcomes:* Applications lead to sustainable student outcomes beyond the grant term

4. *Centralized Coordination:* Applications show how college is intentional about using funds to link students to services in a coordinated manner. This could include using funding to enhance existing programs or establishing centralized coordination to oversee new programs
5. *Immediate Impact:* Applications show how the funding will be put to immediate use
6. *Demonstrated Need:* Applications demonstrate why, in the absence of grant funding, demand for mental health services will not be met by existing or planned services
7. *Equitable Implementation:* Applications demonstrate how program implementation and use of funds will be equitably distributed among students, especially among minority, underrepresented, and/or disadvantaged student populations

A committee of individuals from OTG, OHE, and DMHAS will review applications and grant awards up to the levels described above.

2. **Strategy:** Describe how your school will use the funds, within the four eligible use categories. Why have you chosen this specific approach? Explain your rationale and the supporting evidence behind your plans.
3. **Implementation:** Describe your implementation plan to obligate funds for new or expanded programs by December 31, 2022. Additionally, please list any community or vendor partners you will engage in this work. How will you ensure that resources reach students in a coordinated fashion?
4. **Tracking:** How will you know if programs are working? What outcomes will you measure and track?
5. **Equity:** Describe how your plan will yield equitable outcomes through its design and implementation. Explain any efforts to serve specific groups that may have been marginalized or underserved in the past.

An application must receive at least 14 points, based on the rubric below, to receive a grant. All successful applications will receive the full grant amount. Applicants may be asked to resubmit an application should it not receive the minimum required score.

All awards are subject to the availability of state and federal funds. The grant award is not final until the award letter is executed. OHE will issue notification of the RFP award. The effective dates of the project will be set forth in the notification of the RFP award.

Budget Code Descriptions

100 Personal Services – Employee Salary

Amounts paid to employees of the grantee. Include all salaries for these individuals while they are on the grantee payroll including overtime salaries or salaries of temporary employees. A general rule of thumb is that a person for whom the grantee is paying employee benefits and who is on the grantee payroll is included; a person who is paid a fee with no grantee obligation for benefits is not.

200 Personal Services – Employee Benefits

Amounts paid by the grantee on behalf of employees; these amounts are not included in the gross salary, but are in addition to that amount. Such payments are fringe benefit payments and, while not paid directly to employees, nevertheless are part of the cost of personal services.

300 Purchased Professional and Technical Services

Services which, by their nature, can be performed only by persons or firms with specialized skills and knowledge. While a product may or may not result from the transaction, the primary reason for the purchase is the service provided. Included are the services of medical professionals, architects, engineers, auditors, lawyers, consultants, teachers, accountants, etc.

400 Purchased Property Services

Services purchased to operate, repair, maintain, and rent property owned or used by the grantee. These services are performed by persons other than grantee employees. While a product may or may not result from the transaction, the primary reason for the purchase is the service provided.

500 Other Purchased Services

Amounts paid for services rendered by organizations or personnel not on the payroll of the grantee (separate from Professional and Technical Services or Property Services). While a product may or may not result from the transaction, the primary reason for the purchase is the service provided.

600 Supplies

Amounts paid for items that are consumed, worn out, or deteriorated through use, or items that lose their identity through fabrication or incorporation into different or more complex units or substances.

800 Miscellaneous

Amounts paid for goods and services not otherwise classified above.
